SATURDAY MORNING WORKSHOPS

A-1 **Circle Dialogue Process—Part 1, participants must also take part 2 in the afternoon—Donald Halderman, Jackie Gishop and Trish Charo,

An introductory workshop on the Circle Process, based on the Native American tradition of talking circles, which brings people together to build community and work through conflict or differences. This workshop is interactive and experiential.

A-2 **What Do Mediators Really do Behind Closed Doors? Winnie Backlund

This interactive workshop will include a review of the current research on mediator's behavior in the mediation session, different moves and strategies used by the mediators, and what the effect is on the mediation process.

A-3 **Ethics for Mediators

Mediators are faced with ethical issues and have to make judgment calls to determine how to respond. Participants in this workshop will discuss and respond to ethical scenarios posed by the facilitators in game form. Be prepared to have fun addressing a serious subject. (2 CLE ethics credits will be given)

A-4 **Introduction to NAFCM's Community Mediation Center Manual–Craig Coletta

This interactive workshop will provide participants with a method for ongoing monitoring of the activities of community mediation centers. You will learn about the philosophy and principles underlying the development of the NAFCM manual.

A-5 **Establishing Working Relationships with your Local Municipal Government and County Judicial System

Neighborhood Dispute Settlement of Harrisburg will describe the development of their relationship with local police and District Justices. Participants will learn how to create and fund a partnership, and they will gain an understanding of the minor judiciary.

B-1 **Circle Dialog Process—Part 2 Participants must have attended part 1 in the morning.

B-2 **Decision-making Theory and Practice: Insights for Mediators—Craig Coletta

Participants will learn about a matrix describing the decision making process and will acquire an understanding of the theory and practice of decision making and how it applies to their work. A panel will discuss the relevancy of the matrix to their professions.

B-3 **Measuring Mediator Performance Grace D'Alo

This workshop for administrators and advanced mediators will focus on a methodology for measuring mediator performance. Participants will learn about the performance instrument developed by the Pennsylvania Special Education Mediation Service.

B-4 **Using Peer Mediation in Classrooms and Schools Nannette S. Scheuch

Participants in this workshop will be provided with an overview of Scranton School District's Peer Mediation Program and learn a step by step approach to implementation of peer mediation.

B-5 **What Does Community Empowerment Have to Do With Dispute Resolution—Paul Wahrhaftig

This workshop is a discussion of the history of community mediation and empowerment concepts and how this has evolved over the past 30 years from empowering the participants of the community to case oriented programs designed to serve the public and clear court calendars.
